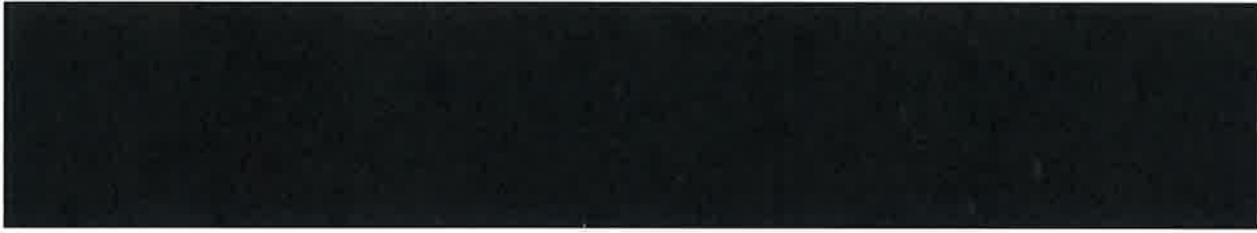

As you are aware, Article IX of Chapter 49, D.R.M.C., gives the manager of public works authority to remove or order the removal of encumbrances on city-owned property, with the term "encumbrances" defined to mean "any article, vehicle or thing whatsoever encumbering any street, alley, sidewalk, parkway or other public way or place." Sec. 49-248 specifically authorizes the manager to invoke the assistance of the Denver Police Department in removing encumbrances.

The purpose of this letter is to request the support of the Denver Police Department and authorize your officers to act on my behalf in assisting public works personnel with the removal of encumbrances associated with the placement and storage of personal property on city-owned property in the following location and time period:

Locations:

In the area generally bounded by Champa, Market, 21st, and 25th Streets

In the area generally bounded by Lawrence, Arapahoe, 25 and 27th Streets

Time period: Starting March 8, 2016, and continuing for 60 days thereafter.

The enforcement action will be governed by the attached protocol, which specifies the roles and relationships of public works personnel and DPD officers in regard to the removal and storage of encumbrances associated with this enforcement action.

The second half of the meeting will be dedicated to messaging, media and outreach. Here is an email I just sent to agency PIOs inviting them to Monday's meeting, summarizing where we are in the discussion, listing next steps and pending action items:

Dear Communicators:

For the past several months, we have been working to address the sidewalk encampments in the Ballpark area. In September, you helped develop messaging and handle media (Denver stepping

up homeless outreach at encampment, Denver

Post<http://www.denverpost.com/news/ci_28803588/denver-stepping-up-homeless-outreach-at-shelter-encampment>). We are about to step up those efforts and we would like to reconvene with you Monday. Please watch for a separate calendar item inviting you to join a meeting of agency representatives. Here is some additional information:

- Since September, the City, homeless outreach workers and other providers have increased efforts to connect those who are living on the streets in and around the Ballpark Neighborhood with essential services.
- This coincides with a significant increase by the Department of Public Works, with the assistance of the Denver Police and Sheriff Departments, to clear debris from the sidewalks in the Ballpark Neighborhood. Public Works has been power-washing and removing trash three times a week from sidewalks near the Samaritan House and Denver Rescue Mission homeless shelters.
- With the November opening of the Lawrence Street Community Center, we had hoped the number of people living on, and the amount of items piling up on, the sidewalks would diminish. Unfortunately, that has not been the case. In fact, this unsafe, unhealthy and inhumane situation is only getting worse, with dozens of people continuing to live on the streets even in dangerous winter weather.
- Therefore, we will be taking the following steps in order to protect people, maintain public health, and respond to mounting concerns from nearby residents and businesses:
 - o Increase from three days a week to five trash removal and sidewalk power washing by Public Works and Sheriff Department work crews.
 - o Encourage members of the public who engage in "drive by" drop-offs of food and other items that there is a better way to give.
 - o Escalate efforts to connect people with services. DPD officers will be:
 - Verbally directing those who remain on the sidewalk to indoor services.
 - o Clarify police enforcement by:
 - Verbally warning folks if they or their belongings are violating city laws (unauthorized camping, obstructing or encumbering the public right of way)
 - Issuing written warnings
 - Issuing written citations
 - Making arrests

Happy Sunday everyone. At Monday's meeting, we will continue and hopefully reach conclusion on several of the items we discussed Friday. The second half of the meeting will be dedicated to messaging, media and outreach. Here is an email I just sent to agency PIOs inviting them to Monday's meeting, summarizing where we are in the discussion, listing next steps and pending action items:

Dear Communicators:

For the past several months, we have been working to address the sidewalk encampments in the Ballpark area. In September, you helped develop messaging and handle media (Denver stepping up homeless outreach at encampment, Denver Post<http://www.denverpost.com/news/ci_28803588/denver-stepping-up-homeless-outreach-at-shelter-encampment>). We are about to step up those efforts and we would like to reconvene with you Monday. Please watch for a separate calendar item inviting you to join a meeting of agency representatives. Here is some additional information:

- Since September, the City, homeless outreach workers and other providers have increased efforts to connect those who are living on the streets in and around the Ballpark Neighborhood with essential services.
- This coincides with a significant increase by the Department of Public Works, with the assistance of the Denver Police and Sheriff Departments, to clear debris from the sidewalks in the Ballpark Neighborhood. Public Works has been power-washing and removing trash three times a week from sidewalks near the Samaritan House and Denver Rescue Mission homeless shelters.
- With the November opening of the Lawrence Street Community Center, we had hoped the number of people living on, and the amount of items piling up on, the sidewalks would diminish. Unfortunately, that has not been the case. In fact, this unsafe, unhealthy and inhumane situation is only getting worse, with dozens of people continuing to live on the streets even in dangerous winter weather.
- Therefore, we will be taking the following steps in order to protect people, maintain public health, and respond to mounting concerns from nearby residents and businesses:
 - o Increase from three days a week to five trash removal and sidewalk power washing by Public Works and Sheriff Department work crews.
 - o Encourage members of the public who engage in "drive by" drop-offs of food and other items that there is a better way to give.
 - o Escalate efforts to connect people with services. DPD officers will be:
 - Verbally directing those who remain on the sidewalk to indoor services.
 - o Clarify police enforcement by:
 - Verbally warning folks if they or their belongings are violating city laws (unauthorized camping, obstructing or encumbering the public right of way)
 - Issuing written warnings
 - Issuing written citations
 - Making arrests

Thanks, Julie. A few big obvious questions/answers:

Why are we doing this? To prevent a public health and safety crisis for the people living outside and for the entire neighborhood.

Where will people go? Homeless advocates say there isn't enough room at shelters. There absolutely is room for people at the various day shelters serving Denver, and same goes for the overnight shelters.

If people aren't allowed here, won't they just go to some other neighborhood? We are working closely with outreach workers and service providers to get people to come inside for shelter and services and ultimately housing.

Are you just going to throw away people's belongings? Absolutely not. We will encourage people to take their belongings with them. If they don't, items will be taken to 1221 Glenarm Place. Items will be available for retrieval at that location Monday through Friday from 12 Noon to 2 p.m.

Aren't you just criminalizing the homeless? Absolutely not. We are trying to protect people's health, safety and welfare by connecting them with shelter, housing and services. The City spends nearly \$50M a year on direct and indirect costs related to homelessness. We continue to add new services and new programs all the time to serve the homeless, including the LCSS, SIB, later this year the Solutions Center, and this spring/summer a new job program where the City will be hiring homeless people to work directly for city departments.

What happens when the Peoria Street winter overflow emergency shelter closes? We are working on a replacement for Peoria as we speak.

Denver plans to clear homeless camps near Samaritan House next week

Homeless camps that first sprung up on sidewalks near the downtown Samaritan House shelter last summer soon will get an eviction notice.

The city plans to provide advance warning early next week and on Tuesday will begin removing any remaining items left on public sidewalks or other public property, according to a notice obtained by The Denver Post and confirmed by city officials.

If the city doesn't take action, officials say, the area will face "a looming public health and safety emergency."

The city is taking a tougher stance toward the camps with a new multi-agency effort. It will mark the first clearing of downtown camps on this scale in recent memory, an official said, though police have conducted smaller periodic sweeps near the South Platte River and also have used a controversial camping ban to move people off the streets.

In recent months, homeless campers have moved around the area near Lawrence Street and Park Avenue after the city has cleared sidewalks for cleaning — as frequently as five days a week in January.

Despite ongoing attempts since September by city departments and homeless outreach groups to connect people to shelters and other services, the camping has persisted. Some people have resisted offers of shelter beds.

"I know for a lot of these people, it comes down to not wanting to be confined to an enclosed area, and some are just here for the legalized marijuana and can't do that indoors," said Daniel Dishman, a frequent visitor of the Lawrence Street Community Center. "More than that, the minimum wage here is too low and the cost of living is too high. You

have to be able to compromise with the homeless. If you don't want their furniture on the streets, give them somewhere else to put it."

Julie Smith, a city spokeswoman, remains optimistic their efforts have begun to make an impact.

"Together, through this intensive and focused effort, we have helped hundreds of people and supported the community," Smith said in a statement to The Post. "However, the health, safety and welfare of those who continue to live outside on the streets and sidewalks is nearing a crisis. This unsafe, unhealthy, unsanitary and inhumane situation must be addressed."

But the plan sparked concerns for John Parvensky, president of the Colorado Coalition for the Homeless.

"It is unfortunate that the city is moving more aggressively to enforce the camping ban ordinance at this time," Parvensky wrote in an e-mail. "While we agree with the mayor's office and businesses that the current conditions of people sleeping on the streets around the shelters is not sustainable, criminalization is not the answer."

The city's one-page notice, titled "Notice of Property Removal and Regular Sidewalk Cleanings," actually relies not on [Denver's 2012 camping ban](#) but on an older ordinance. That law empowers the Department of Public Works to order the removal of articles or vehicles that are "encumbering any street, alley, sidewalks, parkway or other public way or place," while the camping ban more broadly prohibits unauthorized camping on public and private property.

The city says it will begin posting the notice Monday morning, giving a 24-hour heads-up before property removal would start. Outreach workers also will provide the notice to campers.

The notice urges people to move all property, including small electronic devices, medications and important documents, or else the city will take it away. Workers will take cleared property to a secured warehouse on Glenarm Place downtown for up to 30 days, the city says. The notice says people can claim their confiscated property between noon and 2 p.m. on weekdays.

Smith added that the city will ramp up efforts to connect the campers with services at the same time it more strictly enforces city codes.

Also planned: the relaunch of a campaign, called "Give a Better Way," that encourages people who want to help to do so in better ways rather than dropping off food, mattresses and other items, as has been done; and a pilot city jobs program for the homeless this spring or summer.

One impetus cited for the crackdown: the opening in November of the Lawrence Street Community Center, a day center built mostly with city money next to the Denver Rescue Mission men's shelter.

While the center has been used heavily during the day, Ballpark neighbors [told The Post recently](#) that sidewalk encampments have increased nearby overnight. And city officials say the center has provided more options during the day and should give the homeless reason to seek shelter at night.

A city fact sheet on the coming plan says the Rescue Mission's downtown and overflow shelters have been at 79 percent capacity, and no shelters have been turning people away. It also says 650 people have been connected since September with medical and mental health help, food, bus passes, housing and other services, but it doesn't break that down between people who already were in shelters and those staying outside.

"I know that if it wasn't for these shelters there would be a lot more hungry people on the streets," Dishman said. "But a lot of people, for different reasons, aren't social and don't want to be confined with or around other people inside."

Not all campers have wanted to stay in shelters overnight, either.

"The shelters are not a good place for us," Alexis Ross, 20, told The Post in September, describing them as unclean and full of bed bugs. "That is why we are in the street."

Parvensky called the city's property-clearing plan "costly and counterproductive."

"The real solution to this issue is developing additional safe and appropriate emergency shelter and creating enough housing and service options so that those currently living on the streets can move into long-term housing for good."

The city recently moved ahead with a long-discussed "social impact bond" program that in coming years will provide up to 250 of the city's most chronically homeless individuals with supportive housing. But advocates and City Council members note the impact of that program, while laudable, will be limited for the larger homeless community.

Other plans in Denver include the opening later this year of a "solutions" center in Athmar Park that will offer behavioral health services and temporary shelter to homeless people.

But the city still faces more demand for homeless housing than it can provide, leaving shelters as the stop-gap — if people want to use them.

Below and attached is information on the ballpark sidewalk clean up. Please do not distribute widely but administer to your team as you see necessary. If you get any calls from the media, please work with Julie Smith and Jesse Granger from DHS.

Thank you.

- Since last September, the city has worked closely with homeless outreach workers and providers to connect people living on the streets and sidewalks of the Ballpark Neighborhood with shelter, housing and services, including those provided at the new Lawrence Street Community Center. This year alone, we anticipate spending nearly \$50 million on direct and indirect homeless services citywide.
- We have also increased efforts to keep the neighborhood free of trash, debris and waste. Together, through this intensive and focused effort, we have helped hundreds of people and supported the community.
- However, the health, safety and welfare of those who continue to live outside on the streets and sidewalks is a growing concern. Therefore, the City will be increasing efforts to connect people with shelter and services and avoid a looming public health emergency by strictly enforcing various city codes.

- **We will be taking great care to protect the personal belongings of people living on the streets as we intensify efforts to keep the neighborhood clean and sanitary. We will store any belongings that get left behind at 1221 Glenarm Place for up to 30 days. Items can be retrieved from Noon to 2 p.m. Monday through Friday.**
 - **There is shelter space and services available for those who seek it; people do not have to be in these unsafe and unhealthy conditions.**

Hi Evan

Between yesterday and today we have tagged and inventoried 99 bags (55-gallon) full of stuff. We are averaging about 2 bags per cart so about 50 plus carts used in two days. My estimate is that between 50-60 of those bags are items that people voluntarily asked us to store and we issued a claim check to them and wrote their name on the tag and directly on the cart. We have stored at least 17 + bags of stuff for one person between yesterday and today and have probably spent at least 2 ½ hours with this woman waiting and storing items- she managed to carry everything yesterday but somehow accumulate more since yesterday afternoon.

I'm attaching a few pictures of the needles and knives/shanks that we found at the last clean up today and I know other have pictures. Also as I mentioned today, we have opted to discard anything that is soiled with vomit or other bodily excrement as well as items heavily soiled with food waste - so these are likely the items someone may have seen being put in a garbage truck.

I will get a full copy of the inventory forms from the contractor at the end of the week. Also as discussed we will have them separate the couple of bags that we placed the ids and ss cards in from yesterday to make sure they are not discarded after 30 days.
